

The Parentage of Richard Fore (1750-1817)

Some notes to help determine the ancestors of the Marion Co SC / Monroe County AL Fore Family

	Fact- Genetic DNA has linked some with the FORE surname to the FORD surname. One of these families documents their lineage back to Pierre Faure in Manakintown, Va. The connection from Calvin Fore (Culvin) is not well documented, however. It is generally assumed that Calvin (Born 1789 in Buncomb Co., NC or Union Co., Ga) is a son of Archalaus Faure (Born 1747 in Manakintown, Va.) This FORE line is in Buncombe Co, NC in 1817.
1679	Pierre FAURE (FOURI) left London on December 19, 1679 and arrived at Oyster Point, SC on 30 April 1680 on the ship <i>Richmond</i> . He brought with him a wife and 6 children. Frere FOURE of Paris with his family – 8 total appear of the passenger list. Marie, daughter of Pierre Foure and his wife Elizabeth le Marie was baptized in the Threadneedle Street Church in London. If this is the Pierre Foure of the <i>Richmond</i> list, his wife probably had relatives in London before they went there from Paris. (source, South Carolina Historical Magazine, 1941 – Snippet view at Google Books)
1675	Jean Pierre Faure was born 1675. This FAURE was born in France is is accepted to be one of Daniel Isaac Faure's sons. (Born cir 1653 in France & died Aug 31, 1710 in Manakintown, VA (Source Manakintown records)
1675	Pierre Faure, Sr. was born about 1675 in France. He is the son of Daniel Isaac Faure and Mary Chastain. He married Elizabeth Agar (Agee) who was born about 1677 in France. Pierre, his wife Elizabeth and a son Jean (b. 1697) sailed on the ship La Nasseau and landed at James Town March 5, 1701. Pierre Faure and his family settled at Manakintown. His coat of Arms shows that he was from the Faure Family of Auvergne, France. He was naturalized on May 12, 1705. He was a member of the Vestry of the French Reform Church from 1732-1744 until he asked for his discharge which was granted. This family shows up as FORD's on the list of King Williams Parish June 1744 and in their wills.
1699	The Widow Faure arrived on the 1 st Huguenot ship to Manakintown arrives in James City – <i>The Mary Ann</i> , July 31, 1699. Her husband died either on the ship or before the trip. She had 4 children with her. (2 sons, 2 daughters) The 2 sons were Daniel and Jean.
	“James FOREE (pronounced Fo-ra) was a French Huguenot. His several sons spelled their names in various manners. Some after the French fashion, Foree; other dropped the final e, while the remaining dropped the e's spelling it FORD. Of the first James FOREE, or FORD I have no tradition except he was a French Huguenot and Refugee. His son James spoke broken english, lived on the James river in Virginia, and lived to be 109 years old. Peter Ford also settled on James River. He was married four times. His first wife (Judith Maxey) was the mother of fifteen children, among who were Joel, John, Jacab, Daniel, Obediah, and several daughters Sarah, Annie etc. His second wifes (sic) children were Laban and Polly. His third wife was a widow Brooks from who he separated, living together but for a short time. He moving to Kentucky and hearing by

	letter his wife was dead (though she was not as it was afterward proven) married the forth time to the widow Sloan, who was the mother of one son, Peter FORD, Jr. He died at the age of 90 years. Of Peter FORDS Sons Joel remained in Virginia and reared a large family,.... ” (Source – Letter written by Tirey FORD in 1896) James -> James-> Peter
1699	Fact - Stephen FORD had a land warrant out of ye Secretary's office for three hundred acres of land dated January ye 6 th 1699/1700 (source – Warrants for Land in South Carolina 1692-1711)
1699	Fact – Stephen FORD had a warrant out of ye secretary's office for one hundred ninety acres of land dated 19 th January 1699/1700. (source – Warrants for Land in South Carolina 1692-1711)
1700	Fact – James FORD had a Warrant out of ye Secretary's office for five hundred acres of land dated August ye Seventh 1700. (source – Warrants for Land in South Carolina 1692-1711)
1701	Fact – John FORD had a warrant out of ye secretary's office for five hundred acres of land dated August 19 th Anno. 1701 (source – Warrants for Land in South Carolina 1692-1711)
1702	Fact – Stephen FORD had 2 warrants. One for 240.200 dated Sept. 26, 1702 (source – Warrants for Land in South Carolina 1692-1711)
1703	Fact - (source – Warrants for Land in South Carolina 1692-1711) Noe grant to pass for land about hickery hill to Ralph Ames or any other till Stephen FORD is called, taken this 22 nd day 7ber 1703
1703	Fact – a warrant was granted to Ralph Ames Junior for 100 acres of land in Colleton County bounding to ye north on Stephen FORD & on all other sides land not laid out Dated 1 st May 1703 (source – Warrants for Land in South Carolina 1692-1711)
1704	Fact – James FORD had a Warrant for five hundred acres of land dated ye 20 th of 9ber 1704 (source – Warrants for Land in South Carolina 1692-1711)
1704	Fact – James FORD had a Warrant for 1000 acres of land on ye NE side of ye head of Ashly River dated ye 5 th xber 1704 (source – Warrants for Land in South Carolina 1692-1711)
1706	I have in my notes that there is a Stephen FORD in Charleston around 1704-1706. I don't have a source listed.
1707	Stephen FORD had a warrant for 300 acres of land in Collenton County October the 16: 1707 (source – Warrants for Land in South Carolina 1692-1711)
1708	Stephen FORD had a warrant for 500 acres of land in county ye 12 th day of ffebruary 1708/9 (source – Warrants for Land in South Carolina 1692-1711)
1708	The traveler, John Lawson, in his journey through North Carolina in 1708, visited the French Huguenot colony on the Trent River to which some of the Manakin settlers had recently come. (Source – The French Huguenot Settlement of Manakintown, By James L. Bugg, Jr. Published in the Virginia Magazine of History and Biography 61:4, October 1953, pp. 359-392) More information (Source “History of North Carolina by Lambet Lilly, Francis Lister Hawks) “On the revocation of the edit of Nantz by Louis XIV, a number of the persecuted Huguenots had found their way to Virginia, and had

	settled at the Manakin towns (as they were called) on the James River. These good people emigrated in part, about this time, to North Carolina. The clergyman whom they had brought from France, Phillipe de Richebourg, emigrated with them. They made their settlement on Trent River, not far from the present site of Newbern. A portion of them, however, removed further south, and planted themselves on the Santee, where a parish was formed of them, known as St. James. These were accompanied by De Richebourg, who died in South Carolina. This was the origin of the Huguenot families in North Carolina.” The same source describes Swiss and German settlers who settled in the same area at the junction of the rivers the Trent and Neuse. (92 families came over with De Graffenreid and Mitchell)
1709	I have notes that state that members from Manakintown settlement trickled down to the Santee (SC – part of Craven Co. called French Santee) between 1709 & 1712. (No source)
1709	Fact – Dec 14, 1709 Preserved FORD married Mary (Last name unknown) (source SC marriages 1693-1842) – related to the James Ford Family. This line is said to be a line from England. I think its more likely that they are a line from the Huguenot FAURE family(ies) who was/were in the area at the time. Perhaps someone has more information...
1711	Fact – William FORD had a warrant for 640 acres of land in Granvill County ye 14 of April 1711 (source – Warrants for Land in South Carolina 1692-1711)
1716	Fact – March 5, 1716 Joseph FORD married Mary Turkitt (source SC marriages 1693-1842)
1716	Fact – May 6, 1716 Nathaniel FORD married Mrs. Mary King (source SC marriages 1693-1842) Beresfore surname from previous marriage?
1716	Fact – 3 FORD's are listed as residents of the South Carolina Colony. James Ford is listed as a resident in 1779 in the Old 9 th District. 2 entries appear for Nathaniel Ford. The first is as a 1716 SC Petitioner and the second is as a 1717 SC Petitioner. Neither lists a township. There are 2 FORTS listed in the Old 96 th District in 1779 as well. (Drury, Sr. and Moses) (Source – The Colony of South Carolina Records 1716 - 1783)
1722	Fact – April 13, 1722 George FORD married Sarah Oliver (source SC marriages 1693-1842)
1726	In May of 1726 the TUBERVILLE family moved to Plumtree Island (Now called Mush Island) in Halifax County, NC. Prior to that (1713 & 1726) they lived on the Occonee neck of the Marattuck River (Roanoke River) – Present day Northhampton Co. NC
1735	The first movement to the Orangeburg District began. (German & Swiss Settlement)
1737	Nathaniel FORD is listed in the Royal Plats on the Little Pee Dee River as owning a 350 acre plat. 1737/07/15 (Craven Co)
1743	Fact – Francois Faure is listed as a resident of Purrysburg in 1743 (Source – The Colony of South Carolina Records 1716 - 1783)
1748	A Peter FAURE of Berkly Co. SC sold land to William Barrie Jan 7 1748/9 Witnessed by John FERREE. Sarah FAURE renounced her dower.

1749	Preserved FORD was born. (per-zar-ved emphasis on the second syllable) 1749-1829. He built a mill called Ford's Mill. Preserved FORD married Miriam Gaddy (Date unknown) a Barfield, and a Celia (Unknown) who was a widow. He named a son Cooper (named after Joel COOPER of Robeson?) Jesse FORD was witness to Joel COOPER's sale of 200 acres on the southside of Ashpole Swamp to Daniel POWELL of Robeson, 11 Feb. 1811. Note: Thomas COOPER, one of the four COOPER men who arrived in Richland Co. SC between 1811-1820 named a son FORD) descendants of the old Ithamur GADDY acquired the mill from the FORD family. The lands belonging to old Drury HAYS in Haystown bound on a large "Plantation" which adjoins an old gristmill and pond, now called Gaddy's Mill. (Found on a genealogy.com forum post WAGES family)
1750's	Fact – Peter Faure received one of the earliest Orangeburg plats and became the primary surveyor during the 1750's.
1750	There is a Stephen MIDDLETON born in Edgecombe CO NC or Marion Co SC 1750-1812. There are MIDDLETON's in Monroe Co. AL in later years. Could this family have connections to ours? (NASH was later formed from Edgecombe)
1750	The SELLER's family came to Marion Co SC. From Tarboro NC about 1750. (Edgecombe Co.) They were of Scotch, Irish and English descent. William SELLER's headed the family. He settled in Columbus or Brunswick Co. NC on what was called the "Seven Creeks" had had raised six or seven sons. Benjamin SELLER's was born about 1740 grew up and married a BRYANT by whom he had five children. Jordan SELLER's, the oldest of these sons and the only child raised to be grown, was born 16 February 1763. (NOTE: are these dates right? His father would have been a young teenager) Jordan SELLER's died 9 September 1835 at the age of 75 year in Marion CO. SC. Benjamin SELLER's was married 2 times. He had three sons and a daughter from this second marriage. (Source – A History of Marion County, W.W. Sellers, 1902)
1754	There is a Benjamin FORD & a William FORD on the muster roll of Colonel William Eaton, Branvill Co, NC October 1774. (Source Colonial Soldiers of the South 1732-1774)
1754	There is a John FORD listed in Captain Andrews Lewis' Company of Rangers. They were employed on the upper tributaries of the Potomac, and in the Greenbrier River – West Virginia frontier during the era of the French & Indian War. (Source – Virginia Colonial Militia Crozier)
1754	Fact – There is a Thomas FORD and a Thomas FORD Jr., listed on the muster roll of Lieutenant Colonel John Harvey's Regiment, Perquimans Co, NC in Captain Miles Harvey's company. (Source Colonial Soldiers of the South 1732-1774)
1755	Fact - Alexander FORD is on the tax list for Bertie county NC. Bertie County was formed in 1722 from Chowan. (In 1741 Edgecombe is formed from part of Bertie) He is also listed on the 1757 tax list. Is shows him as a planter of barley and living in a 2 person household. Himself and a black female.(Source, Census, Bertie C., Edington District) Unless he is a brother of the father of Richard (or cousin) he can't be related.
1757	Fact - In 1757 Peter FAURE was captain of the Fourhole Company of the South Carolina Militia.
1757	Tobias FORD married a widow Mary Turner Jan 18, 1757. He was a planter in St. Bart. They had several children. March 14, 1760 - Charles , April 7, 1763 - Hannah, July

	16, 1765- Elizabeth, July 15, 1775 Elisa :Nash (appears to be a repeat!) , March 11, 1771 – Isaac, Aug. 9, 1773 – Susannah. A Tobias FORD died April 14, 1773.
1759	There is a James FORD listed as a Captain on the South Carolina Militia muster and pay rolls of Colonel George Gabriel Powell's Battalion serving in the late expedition against the Cherokees from October 1759 to January 15, 1760. (Source Colonial Soldiers of the South 1732-1774) Note: GASQUE , GODBOLT surnames listed (Marion Co SC surnames) In the 1790 census all SC Godbolts are listed in Prince Georges, Georgetown. All the SC Gasque are listed in Prince Georges, Georgetown SC are well. Therefore, I would conclude this FORD is from there as well. On the 1790 census there is a James Ford listed in Prince Georges, Georgetown. James is listed as being the only male in the household with 3 girls/women. (Probably his wife and 2 girls) He owns 3 slaves.
1759	Samuel FORD & Thomas FORD are listed on the muster roll of Captain Moses Shelby's Company, in the regiment commanded by Colonel Richard Richardson, for the period of October 18, 1759 – January 10, 1760, 2 months and 22 days. (Source Colonial Soldiers of the South 1732-1774)
1759	Samuel FORD is listed as a deserter (Dec. 10) on the muster roll of Captain William Scott's Company in the regiment commanded by Colonel Richard Richardson, for the period of October 18, 1759 – January 10, 1760 , 2 months and 22 days (Source Colonial Soldiers of the South 1732-1774) Question – Is this the same Samuel Ford listed above? (1759 Cherokee Expedition) It appears a Joseph Stover deserted as well.
1759	October 21, 1759 (from the List of Carts, Geers etc. Impressed for the use of Colonel George Gabriel Powel's Battalion on the late expedition against the Cherokees) Rec:d from Fran:s McCall, 1 cart appraised by Cap:t Hicks, Cap:t FORD and Nicholas Green at 8.10 but left as insufficient between Rowell's Mill and Mr. Crawfords & which McCall declared he would gladly take again (assuming this refers to James FORD) Other items are listed as well with his name.
1759	The muster rolls of Colonel Geore Gabriel Powell's Battalion of South Carolina Militia in the 1959 Cherokee Expedition for the period of October 6, 1759 – January 10, 1760 lists a James FORD and a Joseph FORD.
1760	The Pay roll of scouts in Colonel Nathaniel Alexander's Regiment, Anson Co., NC Feb 28-19 March 1760 lists a Thomas FORD. (Source Colonial Soldiers of the South 1732-1774)
1762	Fact - There is a Daniel FORE listed on Pitt Co, NC Tax records 1762. Pitt County was formed in 1769 from Beaufort Co. The 1790 census also lists a Benjamin HEARN. This could be a possible link to the Orangeburg SC families. The Faure and Hearn's families were close there. North Carolina Taxpayers, 1679-1790, Vol. 2 lists a William HEARN in Pitt Co. in 1763 as well.
1763	Fact – There is a John FORD listed in the militia of Rowan County NC commanded by Ensign James Smith for 6 days in 1763 in defense of the frontiers of NC (Source Colonial Soldiers of the South 1732-1774)
1763	Judith TUBBERVILLE, daughter of John is listed in his will dated 3 Aug 1763. Could she be our missing JUDITH?
1765	Capt. George TUBERVILLE is listed in a Virginia Northern Neck Land Grant. I-139:

	John Hough of Loudon Co. 2248 A. on Salisbury Plain Run & Cub Run on said Co. Surv. William West. Adj. Andrew Russel, Dennis McCarty, Capt. George Tuberville, Col. Henry Lee, Andrew Hutchinson, Elklicking Run, John Elliott. 22 Aug. 1765 (Source – Virginia Nother Neck Land Grants, 1742-1775, Vol. II)
1766	There is a Johnathan FORD listed on the muster roll of Captian Adam Alexandar's Company, Mecklenburgh County, NC, Clear Creek Militia, June 1766.
1770	There is a John FORD listed in an agreement between Providence and Clear Creek (Now called Philadelphia) NC. Also listed is Michael LIGGET. We later find the LEGGETT family in both Marion Co. SC and Monroe Co. AL. Both John FORD and Michael LIGGET are listed as from Clear Creek. (Source – Sketches of North Carolina, by William Henry Foote, page 246)
1770	James FORD 150 acres in Craven Co. (Royal Plats on the Little Pee Dee)
1771	Jacob Gooyer to James FORD both planters of Craven Co. , Charleston on the SW side of the Little Pee Dee River. This land was sold prior to 1801 to Jesse Barfield.
1772	There is a Daniel FORD listed on the muster roll of John Montgomery's Company.NC Militia (Source Colonial Soldiers of the South 1732-1774)
	Possibility - Richard FORE may have 2 children with unknown names /details. Could this Calvin Fore be a son of Richard? No, Richard was born in about 1750. The 2 unknown children are listed as being born in 1773 & 1775. This doesn't fit the above mentioned scenario. It's probably that if there were children that are unknown they died young. Could Richard and Calvin Fore's father be brothers? Maybe? NASH and Buncombe counties are not close to each other, however. My educated guess is no. There is a Jesse Fore (b c 1787, prob in SC who married a Nancy ?) This line also does not know the parentage of their line past Jesse.
	Fact - The book The Stackhouse Family, Part II, by Walter F. Stackhouse (Marion Couty, 1935) reference states that Richard Fore was of Huguenot decent... form somewhere around Charleston, South Carolina. (Page 114) I have been unable to find this book to verify this information myself. This reference was found on a family tree I printed about 2003 from Family Tree Maker.
1770	James Ford – Plat for land recorded. 150 acres in Craven County SC
1771	Jacob Gooyer sold land to JAMES FORD. Both are listed as planters and of Craven Co, Charleston, SC. This land is on the SW side of the Little Pee Dee River. It was sold prior to 1801 to Jesse Barfield.
1775	James FORD signed what is claimed to be the First Declaration of Independence from the British. This is know as the Meeklenburg Declaration of Independence and is a highly contested document. (North Carolina)
1775	TUBERVEAL, Isaac severed in the Northeast St. David's Parish Volunteer Company under Capt. Robert Lide during 1775. Charleston News, 19 March 1899 (Source – Roster of South Carolina Patriots in the American Revolution)
1775	FORD, George He served as captain of the Saltcatchers Company of the Colleton County Regiment of Foot under Col. Glover during 1775 and was a major during 1776. Apparently, he served as a major in Marion's brigade. Heitman, p. 232; Council of Safety, 16 December 1775; S.C.H.&G., II, 6. (Source – Roster of South Carolina

	Patriots in the American Revolution)
1775	FORD, George Jr. He served as an ensign in the Upper Saltcatchers Company of the Colleton County regiment of Foot under Col. Glover during 1775 S.C.H.& G., II, 6. (Source – Roster of South Carolina Patriots in the American Revolution)
1775	FORD, Thomas He served as a lieutenant in the Upper Saltcatchers Company of the Colleton County Regiment of Foot under Col. Joseph Glover during 1775. I would venture a guess that Thomas and George Jr. are brothers and George is their father?
1775	FORD, John He enlisted on 30 October 1775 in the Volunteer Company of the Colleton County regiment of Foot under Capt. Andrew Cummins. (Source – Roster of South Carolina Patriots in the American Revolution)
1775	FORD, James He served in the second Regiment during 1775 and was under Capt. Thomas Dunbar during 1779 (Source – Roster of South Carolina Patriots in the American Revolution)
1776	FORD, Absalom enlisted in the Fifth Regiment on 11 June 1776 N.A. 853 (Source – Roster of South Carolina Patriots in the American Revolution)
1776	FORD, Elisha b. 24 November 1757, Fairfax Co. VA d. 29 Sept 1833 m. Sarah (last name unknown) 9 March 1784 While a resident of Ninety Six district he enlisted and served six months from sometimes in April 1776 under Capt. Andrew Barry and Col. Wingate. From Sometime in May 1777 he served another six months under Capt. John Barry and Col. Wingate. Sometime in January 1778 he enlisted and served six months under Capt. John Barry and Maj. Brenham. Form sometimes in May 1781 he served six months under Capt. John Barry and Maj. Tulls. After the Fall of Charleston, he served under Col. Roebuck, was in numerous Indian engagements and was in the seige of Ninety Six. (Moved to KY) A.A.2467; X3492 (Source – Roster of South Carolina Patriots in the American Revolution)
1776	FORD, James He serves as a captain of the St. David's Parish Militia under Col Powell during 1776 and was also a captain in Marion's brigade. Council of Safety, 21 February 1776. (Source – Roster of South Carolina Patriots in the American Revolution)
Late 1770's	TURBERVILLE, Absolom who was married to Lucy Windham was killed in battle. AA 7940 A. (Source – Roster of South Carolina Patriots in the American Revolution)
Late 1770's	FORD, Abraham served as a sergeant in the First Regiment N.A 853 (Source – Roster of South Carolina Patriots in the American Revolution)
1777	Nash County NC formed from Edgecombe Co. (Edgeconbe formed in 1741 from Bertie Co.)
1778	Fact – George FORD, Stephen Ford and Stephen Ford, Jr. are listed on the list of Petit Jurors for the parish of Prince George 1778. James FORD, Jr. is on the Petit Jorors list in the category of unknown.
1779	FORD, Denham (Dunham) He served as a sergeant in the First Regiment, was court-martialed (sic) on 22 September 1779 on the charge of desertion and was acquitted. During 1780, he served as a sergeant in the First Regiment under Capt. Charles Skirving. S.C.h. & G. XVII, 29, Salley, Doc. p. 41 N.A.246, N.A.853 (Source – Roster of South Carolina Patriots in the American Revolution)
1779	FORD, Benjamin He served as captain of the galley Carolina from 3 August 1779 to 3

	March 1780. A.A. 2463 ½ (Source – Roster of South Carolina Patriots in the American Revolution)
1779	FORD, James He served twelve days as a lieutenant in the militia during 1779 under Capt. Thomas Jones and col. Thomas and was a major under Col. Roebuck during 1781 and 1782. In addition, he was at some time a captain and major. (Source – Roster of South Carolina Patriots in the American Revolution)
1780	Found in “An Abstract of North Carolina Wills” a will of BOWLES, Benjamin. Thomas and John are listed as brothers. Mary Ford is listed as a sister. (Surry Co. - formed in 1771 from Rowan. This county is across the state from the area our FORE's were in)
1780	Found in “An Abstract of North Carolina Wills” a will of POUND, Mary with daughter Anne Harrison. Mary Wilson, MaryAnn Clendening and Hannah FORD, . Son John FARR by a previous marriage listed. (Onslow Co – formed in 1731 from New Hanover) The same book lists a Benjamin Johnston with wife Mary, Benjamin, Sarah, Pamela, John and Thomas, Phereba HEARN, Hester Thompson, Filany HEARN and Christie Johnston. 1779. The HEARN families were close to the FAURE family in Orangeburg SC. This could suggest a possible link. There is one DUKE family listed in Edgecombe Co, 1743.
1780	TUBERVILLE, George He served as a corporal in the fourth regiment under Capt. H Davis during January 1780. N.A. 246: N.A. 853 (Source – Roster of South Carolina Patriots in the American Revolution)
1780	FORD, Elijah He served in the militia under Cols. Casey and Waters before and after the fall of Charleston C.S. A.A.2466; X2511 (Source – Roster of South Carolina Patriots in the American Revolution)
1781	FORD, Robert He served in the Militia before the fall of Charleston. (Source – Roster of South Carolina Patriots in the American Revolution)
1781	FORD, Stephen He served in the militia under Col Casey before the fall of Charleston. (Source – Roster of South Carolina Patriots in the American Revolution)
1780	FORD, James He served in the militia under Col. Waters after the fall of Charleston. (Source – Roster of South Carolina Patriots in the American Revolution)
1780	FORD, Thomas he served two hundred seventy-two days under Capt. Peter Youngblood. The date is unknown. He also served in the militia before the fall of Charleston and was under Col Waters after 15 May 1780. In addition, he served one hundred thirty-two days in the militia as a horseman under capt. John Lindsay and Col. Waters from 17 July 1780 to 20 Jun 1781. In addition he served two-hundred seventy-two days as a horseman during 1782. (Source – Roster of South Carolina Patriots in the American Revolution)
1781	FORD, Hezekiah He served under Capt. Thomas Stake in Sumter's brigade and was taken prisoner during 1781. During 1782, as a lieutenant, he was on the Orangeburg Expedition under Capt. Taylor and Gen. Henderson. A.A.2472; X428; C.S. (Source – Roster of South Carolina Patriots in the American Revolution)

1781	FORD, Edward He served as a sergeant under Capt. Joseph Dawkins in the militia from 23 May 1781 to 16 August 1782. C.S; A.A.2465; O416 (Source – Roster of South Carolina Patriots in the American Revolution)
1781	FORD, John He served one hundred seventy days as a horseman under Col. Casey during 1781. (Possibly under Capt. John Lindsey) (Source – Roster of South Carolina Patriots in the American Revolution)
1781	FORD, Gardner He served under Capts. Thomas Starke and Taylor in Sumter's brigade and provided beef, wheat and oats for militia use during 1781 and 1782. C.S; A.A.2488: S540 (Source – Roster of South Carolina Patriots in the American Revolution)
1781	FORD, Albert He served seventy days in the militia on Marion's brigade during 1781 and 1782. In addition he supplied beef for continental use during 1781. Gregg, pg 407, C.S. N193, A.A.2463A. (Source – Roster of South Carolina Patriots in the American Revolution)
1781	FORD, John He served in the State troops under Lt. Col Samuel Hammond during 1781. (Source – Roster of South Carolina Patriots in the American Revolution)
1781	FORD, Stephen He served five hundred days as a horseman under Capts. John Liles, Edward Kelly and Col. Waters from 1 June 1781 to 26 February 1782 and from 22 May to 22 June 1782, he served under Capt. James. (Source – Roster of South Carolina Patriots in the American Revolution)
1781	FORD, Tobias He served as an ensign in the First Regiment during 1781 and was later a lieutenant in Marion's Brigade. (Source – Roster of South Carolina Patriots in the American Revolution) He is probably related to the Tobias FORD I listed in 1757 married to Mary Turner.
1782	Fact – Archelaus FORE is found in the taxpayer records in Surry Co. NC (source North Carolina Taxpayers, 1701-1786) Probably related to the Stokes County FORE, Peter Fore on the 1790 census. This is the family Calvin Fore is assumed to be a part of.
1782	FORD, Malachi He served one hundred eighty-two days in the militia during 1782. (Source – Roster of South Carolina Patriots in the American Revolution)
	FORD, Thomas He served in the state troops under Lt. Col Samuel Hammond. (Source – Roster of South Carolina Patriots in the American Revolution) Dates unknown
1782	FORD, George He served ninety-three days in the militia on horseback under Captain Isaac Youngblood during 1782. C.S.; A.A.2469; Y274 (Source – Roster of South Carolina Patriots in the American Revolution)
1782	FORD, Isaac He served ninety-three days on horseback in the militia under Capt. Isaac Youngblood from February to December 1782 C.S; A.A.2472; X428; C.S. (Source – Roster of South Carolina Patriots in the American Revolution)
1782	FORD, Moses He served forty days in the militia during 1782. (Source – Roster of South Carolina Patriots in the American Revolution)
	Note: There are no FORE's, FAURE's or TUBERVILLE's listed in the Roster of South Carolina Patriots in the American Revolution. I have looked for the same names in Loyalist list and have found no FORD's or the above mentioned names.

1782	Fact – Richard and Daniel Fore show up in census records and early tax records in 1782, Nash County NC. Our Richard Fore would have been about 32 years old at the time. (source North Carolina Taxpayers, 1701-1786) An abstract of North Carolina Wills lists a Michael HEARN in Edgecombe County in 1788. (NASH county is adjacent to Edgecombe Co. and was formed from Bertie Co. in 1741. - although you can find earlier records from Edgecombe starting in 1732) The wife's name is listed as Michael. This is probably a transcription mistake. In the same year there is also a James HERN listed. He has a wife named Elizabeth and children. The HEARN families were close to the FAURE family in Orangeburg SC. This could suggest a possible link or be completely incidental.
1785	Jesse FORE is born in NC. He married in 1815 to Nancy Davis in NC. She is listed as being born in SC
1786	William FORE is born. He was the son of Richard FORE. NOTE: Our Richard Fore's son, William(B. 1786) , married Elizabeth Tuberville. The Tuberville family was from NC prior to living in Marion County SC. (need to confirm it's the same family) If so, then this connect makes it seem more likely that the NC Richard Fore is our FORE relative. The Tuberville's were not in Nash Co, however. Other family connections would be great to find.
1786	Fact – Laurent, Son of Jean Faure, of Bordeaux & Sophie Jeanne marries Elizabeth Pigeot de Louisburg, daughter of Jean Baptiste Pigeot de Louisbourg, of St. Domingo, 3 feb, 1786 (Source – South Carolina Marriages 1688-1799)
1787	Fact – John FORD is listed on the 1787 Davidson CO. tax roll with Isaac and Lewis Ford; 3 taxables. North Carolina Land grant. Purchased land in Sumner Co. where the Virginia line crosses Puncheon Camp Creek (became Smith Co. Tennessee. Kentucky was still part of Virginia)Purchased land on Mill Creek (Davidson Co.) in 1789 Found in the 1770-1790 census of the Cumberland Settlements in the Davidson County section. This is the area north of present day Nashville, Tennessee. At that time it was called Washington Co, NC and became Davidson Co, NC in 1783.
1787	Fact – Lewis FORD was listed with John and Isaac FORD on the 1787 Davidson County tax roll with 3 taxables Found in the 1770-1790 census of the Cumberland Settlements in the Davidson County section
1788	Fact – 3 Feb 1786 Laurent FAURES married Sophie Jeanne ma Pigeot de Louis (source SC marriages 1693-1842)
1789	Calvin Fore is born. (Born 1789 in Buncomb Co., NC or Union Co., Ga) is assumed to be the son of Archalaus Faure (Born 1747 in Manakintown, Va.) This FORE line is in Buncombe Co, NC in 1817. I do not know what documentation this line has of this birth place or if it is just an assumption. Buncombe County is in the mountain area of NC with Asheville as it's county seat. This is clear across the state from the home place of our FORE family (NASH)
1790	13 September 1790, Edgecombe County NC deed book 6, p.3 :Ithamur Gaddy of Robeson County to Joseph Phippen of Edgecombe couty ... John COOPER as a witness. Is this John COOPER a son of William COOPER who married Marry/Polly HARRISON? (William COOPER is the son of Benjamin COOPER and wife Elizabeth of Granville County? Did this John COOPER died in 1791 leaving 2 sons?0 NOTE: all this was taken from a personal post at genealogy and found in the WAGES family

	forums. This COOPER family has connections to the FORD family in Marion Co, SC.
1790	Fact – Col. James FORD participated in the expedition against the Indians at Muscle Shoals in June 1787. He was also summoned from Tennessee Country for jury duty by the Superior Court of Law and Equity May, 1790 (defendant in law-suit) Found in the 1770-1790 census of the Cumberland Settlements in the Davidson County section
1790	The HUTTO family is found in Orangeburg SC records (6 heads of households in 1790 and are found no where else in the state) and Monroe County AL records. This seems to be an incidental connection at best.
1790	Fact – The 1790 census of Halifax District (Nash County NC) shows a William Fore with Daniel Fore also listed. William FORE is listed with one male 16+ (Himself), 3 sons under 16 , his wife and one slave. This makes his birth around 1750 like Richard. Could he be a brother of Richard?
1790	The Georgetown, Prince Georges Census shows several FORD'S. James is listed along with Stephen, Preserved, Nathaniel, George and Joseph. There is also a “hephen” listed which is probably another Stephen.
1790	The Georgetown, Prince George census also has a Richard listed in the same section. Mary Grant lists him as a Richard Force. Looking at the actual census I am not sure I agree. I appears to be another FORD. There is a high mark at the end that suggests a letter d, or even an i with a dot. (Making it Fori? Or maybe Foui?) Ford seems the most likely. It looks very similar to the other FORD's. The American Genealogical Index is the only item that comes up when Richard FORCE is searched on Ancestry.com It refers back to the head of households on the 1790 census. There are a few other FORCE entries from SC when you look at the 1850 census. Only one could have possibly been alive in 1790 – a girl, Patsey is a FORCE by marriage and is listed as mulatto. (Her husband is listed as Alphine) Listed in the RICHARD FORCE household is 1 male over 16, 4 sons under 16 and 3 females. This is possible. I have in my notes that there are 2 unknown sex Fore children born in 1773 and 1775. I do not have documentation for this nor do I have a clue where it came from. (Possibly from someone else's research and I got the information early on before I learned to verify everything!) This matches up to the records perfectly. This would make our FORE probably related to the James FORD who in 1759 was a captain in the SC militia. It would also make us related to the other area FORD's. Richard can't be a son because it seems James is pretty well documented. Maybe James has a brother who is Richard's Father? The other scenario is that a researcher found the record and added the unknown children to Richard in order to make the “connection” work....
1790	Richard FORD and Richard FARE Sr, are found on the 1790 census in Fayette NC, Anson CO. Richard FORD has 3 males over 16 listed 3 males under 16 and 3 females. Richard Sr, has 1 male over 16, 2 females and 1 slave listed. Anson Co, was formed from Balden county in 1750. It is a county on the border of NC / SC
1790	There is a Richard FORD on the Abbeville SC census. (96 th District) 3 free White males over 16, 1 under 16, and 5 females are in the household.
1790	Fact - The 1790 Federal Census lists a Francis FORE in Rockingham Co.NC . It lists 1 male 16+, 1 male under 16, 9 free females and 2 slaves. Rockingham was formed in 1785 from Guilford Co. Guilford was formed in 1771 for Rowan and Orange Counties. Rockingham is in the Stokes Co. area and there is probably a relationship between

	Francis and the Stokes Co. FORE's. On the ancestry.com message board there is a query looking for verification of the children of Francis FORE and Mrs. Susannah Walker Chenaut. They are asking for verification / sources than lists the names of the children as Patsy, Betsey, Polly, William and Mary.
1790	Fact - The 1790 Federal Census lists a Peter FORE in Stokes Co. NC There are 3 males 16 + in the household, 5 males under 16, 2 free females, and 5 slaves.
1791	Littleberry FORE married Mary Gwin 5 April 1791 in Stokes Co. NC Source – North Carolina Marriage Collection 1741-2004 Constant Ladd was the witness.(This family is probably related to the line of Calvin Fore. I haven't researched this line yet) A month previous, March 5, 1791 a Julius FORE witnessed the marriage bond of Seth Allday to Sarah Bozewell. Constantine Lad was the bondsman. (Source – North Carolina Marriage Bonds, 1741 - 1868)
1794	Sept. 16 TUBERVILLE, Joseph , Mary (Wife), Joseph, Sampson, Samuel, Rhonda, Milley; Bunt, William are found in Sampson Co NC (Source – An Abstract of North Carolina Wills) A few year later in the same county we find 1794, Feb 18, TUBERVILLE, Sampson, (Turbyville, properly D'Urberville), Alfred, Tempe (Wife) Side note: a little further up the page I noticed a Zilpha in the family of Samuel Sellars. It caught my attention because of Richard Fore having a daughter named Zilpha.
1797	Fact Aug 12 th Daniel FORD witnessed the will of Drury Smith. Sons: George James, John and the rest of the chn. Viz: Elliot, William, Sarah, Elizabeth Cheek, Mary FORE. EXR: Wife Sarah, John Smith. Also witnessed by Henry Vaughn. Laurens Co. SC (96 th district)
1798	Fact – There is a Joel Fore born 1798 who married a Mary Grant. He is found in NC around Stanford, in Lee County about 1840. This family has been unable to follow the line further back. (Lee county was formed from Moore & Chatham County in 1907. Moore was formed in 1784 from Cumberland. Chatham was formed in 1777 from Orange Co. Orange Co. is in the central section of the state and was formed in 1752 from Johnston, Bladen and Granville Counties.)
1799	Fact- A deep dated 28 Sept 1799 shows that land described as being north of the Great Pee De River was sold to Richard Fore. This land had been granted to John Sanders (82 acres) on 6 Feb 1794 and transferred to Littleton Sanders. Additional land in the sale (100 acres) had been granted to John Sanders on 1 July 1793 and transferred to Littleton Sanders. (Marion County Deed Book A, Page 91)
1803	Fact - The Statues At Large of South Carolina lists John Fore as a commissioner of the roads and bridges on the north-east side of the Great Pee Dee. (13 names listed – Thomas GODBOLT, Andrew Paul, William Bellune, William Bethea, Thomas P. Wickum, James Crafford, Levi Gibson, Joseph Greaves, Robert Hodges, Charles Mood, Jr., Thomas Harley, John Holland and John Fore) I found this book at Google Books.
1805	John FORD is listed as living in the John Ford Fort near the Louisiana line in 1805. FORD and a party of Carolina emigrants came over an ancient Indian trail which begins at the Occomulgee River in Georgia (Columbus Ga?) and ended at the Mississippi River where Baton Rouge is located. FORD built a home located approximately 3 miles north of Ford's Creek landing and south of Sandy Hook Mississippi near the Pearl River almost to Louisiana, in Marion Co. Mississippi. (source : Fordcreeklanding.com apparently a future subdivision) Another source has them arriving later. “John Ford, the

	father of Martin, Calvin and John William, came with his wife Lydia Powell, and their children from Marion District SC in 1829. The family and party, which consisted principally of his wife's people, the POWELLS, made the journey overland. John FORD's wife was from Pennsylvania, but they were married in South Carolina. His mother was Virginia Barfield. (source – rootsweb.ancestry.com Marion County Mississippi Gen web. From Interview with Miss Mattie FORD) Marion County Mississippi was named in honor of General Francis Marion of South Carolina.
1817	Broughton family was from St. John's Parish, Berkely Co SC. Related to the Ragin and Duke Families of Sumter District. Nathaniel Broughton lived in an area called Halfway swamp in Sumter District (Clarendon Co, SC) He married Elizabeth Regan (Ragin) and they had 3 children, Nathaniel Jr., John (Later lived in Green Co GA) and Edward (Stayed in SC) The. Nathaniel Broughton Jr. left Sumter district (Clarendon CO.) in 1816 for Alabama. He married Sarah Bembow. He arrived in Monroe Co. AL in Jan. or Feb. 1817.
1820	Fact – The Finklea line in Marion county had some who moved to Monroe County, Alabama (Willis Finklea b. 1800 in Marion County, SC died in 1845 in Monroe County, AL He was married twice. 1st marriage was to Mary Tart, daughter of Enos and Susanna Tart. Second marriage was to Margaret Bethea. A second Willis Finklea was born around 1745 and died 28 Aug 1837 in Monroe Co AL. He married Martha Smith ca. 1772. The 1790 census for Prince George Parish indicates Willis is head of a household with 11 members . Coincidentally, one of his sons is also named Willis – but is not the above mentioned.)
1820's	Fact – The TUBERVILLE line in Marion county has some who moved to Monroe County, Alabama.
1828	Fact- Hodge Middleton (1820 Marion Co. SC district) married in Monroe County Alabama abt. 1828
	The Bethea Family has both Marion Co SC and Monroe Co Al ties

Conclusion? More research is needed.

Is Richard Fore a descendant of the Charlestown / Orangeburg Family or the Manakintown Faure's?

Based on these notes I feel that Richard Fore was in Nash County NC prior to moving to Marion County SC. Beyond that point he jury is still out. It is documented that Richard is from the Charlestown, SC area. This makes the theory that he is a descendant of the Pierre Faure family originally of Paris, France who were in Charlestown SC in 1680 more likely than him being a descendant of the Manakintown Faure Family. The only family I have found with connections to both Orangeburg and Monroe County, AL is the HUTTO family. (German family) I am still looking for connections between Nash Co (Halifax Districk, Edgecombe county) and Orangeburg. Connections between Purrysburg and these NC locations can be researched as well. The question of Richard's parentage may only be answered by DNA testing. Unless he is listed in birth records, yet to be found, it will be hard to get definite proof.
